Rules:

Current IJF contest rules will be in force with the following exceptions

- Mouthpieces are allowed
- No golden score (referee & judges will decide ties)
- No Kansetsu Waza (Arm Bars) in the Novice Divisions.

Members of OJA Promotion Board will be in attendance

Players (13 years and older) may enter and will compete as seniors and are subject to senior rules

1 mat will be used

If you accomplish 6 wins you are done competing

Players will be allowed to play up and then play back down the line to achieve 6 victories

Players with 4 or more victories will be awarded a gold medal. Players with 3 victories will be awarded a silver medal. Players with 2 victories will be awarded a bronze medal.

Kohaku Pooling :

For Men's Divisions:

Senior novice division (White through green belts)

Senior advanced division (Sankyu and higher)

For Women's Divisions:

All Ranks (As there have been only 1 or 2 women that have ever attended the event in the past)

The winner of the Men's Novice Division will be allowed to start the advanced division if so desired.

Pooling will be determined by rank, then lightest to heaviest (within each rank)

Teens competing who are blue (Sankyu) or purple (Nikyu) belts will compete in the senior advanced division

All matches are 3 minutes, with 1 minute between matches.

All contestants are guaranteed at least two matches.

Eligibility - All entrants must be current members of USA Judo, USJA, or USJF (please have membership before coming to the event, no membership will be available at the event unless done electronically)

Rank Awards - Batsugun will be awarded on the spot for competitors who defeat 6 competitors of **their rank or higher** by the end of competition.

Sanctioned by USA Judo. *The Tournament Director reserves the right to make any necessary changes in the best interest of the sport and the contestants.*

1. Acknowledge that I am familiar with the sport of Judo & understand the rules governing the sport of Judo.
2. Agree that, prior to participating, I will inspect the mats, equipment, facilities, competition pools or divisions, & the elimination or scoring system to be used. If I believe anything is unsafe or beyond my capability, I will immediately advise my coach, supervisor &/or a tournament official of such conditions & refuse to participate.
3. Acknowledge & fully understand that I will be engaging in a contact sport that might result in serious injury including permanent disability or death & severe social & economic losses due not only to my own actions, in-actions or negligence, but also to the actions, in-actions, or negligence of others, the rules of the sport of Judo, or conditions of the premises or of any equipment used. Further, I acknowledge that there may be other risks not known to me or not reasonably foreseeable at this time.
