WARNING! WAIVER & RELEASE OF LIABILITY & AGREEMENT TO PARTICIPATE IN THE JUDO EVENT

In consideration of being permitted to participate in any way, including travel to and from, in any Judo tournament, practice, clinic & related events & activities of U.S. Judo, Inc. operating as USA Judo, Oklahoma Judo Association, & First Southern Baptist Church.

- 1) Acknowledge that I am familiar with the sport of Judo & understand the rules governing the sport of Judo.
- 2) Agree that, prior to participating; I will inspect the mats, equipment, facilities, competition pools or divisions, & the elimination or scoring system to be used. If I believe anything is unsafe or beyond my capability, I will immediately advise my coach, supervisor &/or a tournament official of such conditions & refuse to participate.
- 3) Acknowledge & fully understand that I will be engaging in a contact sport that might result in serious injury including permanent disability, traumatic brain injury (TBI) or death & severe social & economic losses due not only to my own actions, inactions or negligence, but also to the actions, in-actions, or negligence of others, the rules of the sport of Judo, or conditions of the premises or of any equipment used. Further, I acknowledge that there may be other risks not known to me or not reasonably foreseeable at this time.
- 4) Knowing the risks involved in the sport of Judo, I assume all such risks & accept personal responsibility for the damages following such injury, permanent disability, or death.
- 5) Release, waive, discharge & covenant not to sue, Jim Walker, Tim Davis, Justin Anthony, The United States Judo, Inc. operating as USA Judo, the USJA, USJF, ATJA, AJJF, Oklahoma Judo Association, & First Southern Baptist Church, together with their affiliated clubs, their respective officers, administrators, directors, agents, coaches, & other employees or volunteers of the organization, event officials, medical personnel, other participants, their parents, guardians, supervisors & coaches, sponsoring agencies, sponsors, advertisers & if applicable, owners, lessors & lessees of premises used in conducting the event, all of whom are hereinafter referred to as Releases, from any & all claims, demands, losses, or damages on account of injury, including permanent disability & death or damage to property, caused or alleged to be caused in whole or in part by the negligence of the Releases or otherwise to the fullest extent permitted by law.

Acknowledge fully that each participant will be engaging in activities that involve risk or serious injury, including permanent disability and death, and a severe social and economic losses which might result not only from their own actions, inactions, or negligence, but the action, inactions, or negligence of others, the rules of play, or the conditions of the premises, or any equipment used. Further, that there may be other risks not known to us or not reasonably foreseeable at this time. 3.
