Sanction: This tournament is sanctioned by USAJudo (USJI) as an **Open Tournament**.

Eligibility: Any Judo player, currently an active member of USAJudo, USJA, USJF, AJJF or ATKJA, (proof of membership must be in hand at registration).

Scoring System: Divisions with 6 or fewer will compete in the Pool System. Those with 7 or more will compete in Pool Knockout/Repechage System.

Set Up: 2 mats will be used;

Divisions:

Kata: Nage-no-kata; and Katame-no-Kata (Males, Females or Mixed teams).

Advanced (Brown & Black Belt) Men: 17+ years old (Weight divisions to be determined by registration). National Weight Divisions will be used if there is sufficient registrations.

Novice (White-Green Belt) Men: 17+ years old (Weight divisions to be determined by registration).

Women (all ranks): 17+ years old. (Weight divisions to be determined by registration).
(Note: Modifications to standard weight divisions may be made to insure competition.)

Masters Men: 30+ years old. 10 year age divisions (30-39, 40-49, 50-59), weights to be determined by registration.

Masters Women: 30+ years old. Age & weight divisions to be determined by registration.

Ne-Waza: Men only, all ranks. Rules will be the same as Judo ground work rules, except that players will begin at the mat center, kneeling on one leg with standard Kumi Kata. since this is a test case with a reduced fee, only standard Judo Medals will be given.

Junior Boy's Divisions & Girl's Divisions: Bantams (5-8), Intermediates (9-12) & Teens (13-16 years old) divisions, divided by weights to be determined by registration [2 year divisions (i.e., 5-6, 7-8, etc.) are normally used, dependent upon registration.] **Minimum age 5 years old.** **(Note: Juniors who are at least 13 years old may also compete in the Senior & Ne-Waza Divisions for the additional fee & will compete under Senior Rules; Masters may also compete in the Senior & Ne-Waza Divisions for the additional fee. (Blue & Purple Belt Boys will compete in the Advanced Senior Division. No junior will compete against anyone more than 15% heavier, unless requesting to be moved up from an uncontested division by the coach, parent or competitor).**

The Tournament Director reserves the right to make modifications to the weight & age divisions to make competition in uncontested divisions.

Rules: Current (2018) IJF Rules & Sporting code will be in effect with standard modifications concerning Shime-waza & Kansetsu-waza for juniors. U.S. national rules will be in effect for situations not covered by the IJF rules (i.e.: Vacating uncontested divisions, etc.)

Rule exceptions:

Mouthpieces (mouth guards) will be allowed.

There will be no Kansetsu-waza allowed in the Senior Novice, & all Teen Divisions. Uniforms must conform to 2018 standards.

Competitors in Ne-Waza Division must stay in kneeling position or lower on the mat, and will be penalized should they stand up prior to the match end.

Awards: Each 1st, 2nd & 3rd place winner in all Judo divisions will receive a cast medal.
Each 1st, 2nd & 3rd place winner in the Ne-Waza divisions will receive a standard medal

Team Trophies: 1st, 2nd & 3rd place Team Trophies will be awarded at the end of the tournament based on the following point system:
Each 1st place=3 pts.; Uncontested 1st place =1.5 pts.; 2nd place =2 pts.; 3rd place=1 pts.

Weigh-in Times:

8-9:00 PM Friday, June 14, 2019 at the tournament site (All divisions).

8-9:30 AM Saturday, June 15, 2019 at the tournament site [All Kata, Masters & Juniors (5-16 year old) divisions].

8 AM-11 AM Saturday, June 15, 2019 at the tournament site (All Senior & Senior Novice divisions).

Referee Clinic: 9:00-9:30 AM Saturday.

Referee Exam: 9:30-10:00 AM Saturday.

Kata competition: 10:00 AM. Saturday

Masters & Teens (13-16 yr. olds) competition: 15 minutes after completion of Kata awards.

Juniors (5-12 yr. olds) competition: 15 minutes after Master's & Teen's awards.

Women, Novice Men & Advanced Men: 15 minutes after Juniors awards.

Ne-Waza Divisions: 15 minutes after Senior Divisions and will not count toward the Judo Team Awards

Seniors-4 minute matches; Juniors, Novice Seniors, Masters & Ne-Waza-3 minute matches.

Referee Exams: Testing for Local & Regional Referee (through USAJudo or USJA) will take place on the day of the tournament. For out-of-state candidates the results of the exam & fees will be forwarded to the candidate's state referee commission. Candidates must inform the tournament director in advance of your desire to be examined.

Directions

From Dallas: Take US 75N to Atoka, OK (the road changes its designation to US 69N), take US 69N to the Indian Nation's Turnpike, take I.N.P. N to Henryetta, (it becomes US 75N), take US 75N toward Tulsa, exit at I-44E, take I-44E to Lewis Ave., exit & turn left (north), take Lewis to E. 21st St., S. turn left for about 0.5 miles to Utica Ave. Turn left on Utica Ave. go about 0.5 miles to the Cascia Hall sign on the left. Turn left into the parking lot, the gym will be up the ramp to the right.

If coming from Oklahoma City or Lawton: Take I-44 E to Tulsa, take the I-244 exit to the intersection of US 64/OK 51 towards Broken Arrow. Take the Lewis Ave. exit & turn right (South) onto Lewis Ave. to 21st St. S., Turn right (West) of 21st St. S. to Utica Ave & Turn left onto Utica. The Utica Ave. entrance to Cascia Hall is closest to the Gym & will be on the left, with a Cascia Hall sign on the fence.

From Arkansas: Take I-40 W to US 69N, take US 69N to US 169S, take US 169S to Memorial Blvd., exit & turn right, take Memorial Blvd. to E. 21st St., S., turn left & go 4.5 miles to Utica Ave. Turn left onto Utica Ave for 0.5 mi. The Utica Ave. entrance to Cascia Hall is closest to the Gym & will be on the left, with a Cascia Hall sign on the fence.

From Missouri: Take I-44 W to Tulsa, exit at US 169, take US 169 S to Memorial Blvd., exit & turn right, take Memorial Blvd. to E. 21st St., S., turn left & go 4.5 miles to Utica Ave. Turn left onto Utica Ave for 0.5 mi. The Utica Ave. entrance to Cascia Hall is closest to the Gym & will be on the left, with a Cascia Hall sign on the fence.

- 1) Acknowledge that I am familiar with the sport of Judo & understand the rules governing the sport of Judo.
- 2) Agree that, prior to participating, I will inspect the mats, equipment, weapons, facilities, competition pools or divisions, & the elimination or scoring system to be used. If I believe anything is unsafe or beyond my capability, I will immediately advise my coach, supervisor &/or an event/activity official of such conditions & refuse to participate.
